

2019 Meeting Minutes

The Annual General Meeting (AGM) - for 2019 was held May 14, 2020 as a virtual meeting. Raymond Doucette called the meeting to order at 7:00 pm with 57 members and 4 guests (Mike Hurley - CUDIC, Colleen Roberts - CUDIC, Tammy Mercier - Atlantic Central, Renel Doucet - Caisse Populaire de Clare) in attendance.

Confirmation of Quorum and Proper Notice of Meeting – Darryl LeBlanc confirmed that a quorum existed, so the meeting could begin.

One Minute of Silence - was observed in honour of past members, victims of the recent shooting in Nova Scotia, and the helicopter crash.

Approval of Agenda - moved by Cecile d'Entremont that the agenda be accepted as presented in the AGM Booklet, 2nd by Brian Grant.

Motion Carried.

Approval of the Minutes of the last Annual Meeting - Danielle Boudreau made a motion that the minutes for the April 17th, 2019 AGM be approved. The motion was 2nd by Holly d'Entremont.

Motion Carried.

Business arising from the Minutes - there was no new business arising from the minutes.

Chair of the Board of Directors' Report – Chairman Raymond Doucette, gave a summary of his report which is included in the AGM Booklet on page 6. He was pleased to share that 2019 was yet another year of progress, growth, and achievement for Coastal Financial. He mentioned that CFCU had purchased a house on Vancouver Street to help alleviate the housing shortage for doctors and interns. He also made reference to CFCU's continued community involvement and referred attendees to review the many organizations supported as outlined on pages 12 and 13 of the AGM Booklet. He thanked the Board, CEO, staff, and loyal members for the credit union's success. **Chief Executive Officer Report** - CEO, Rick Doucette, stated that his report is on page 7 of the AGM Booklet. 2019 was a great year financially. Assets grew by \$17 million to \$182 million and total loan growth exceeded 10%. Our strong financials are a result of the partnership that CFCU has with its members. Rick thanked his team for their hard work and dedication, the board for their guidance and the members for their continued support.

Auditor's Report - Gloria Banks, of the accounting firm Grant Thornton LLP, presented a brief review of the independent auditor's report and the procedures that Grant Thornton uses in order to provide the report and their opinions. Grant Thornton appreciates the support they receive from the management and staff of CFCU during the preparation of the financial statements. There were no recommendations for improvements. In closing, Gloria Banks thanked the staff and the branches for their assistance during the audit.

Financial Statement - Rick Doucette, CEO, presented a summary of the financial statements emphasizing that 2019 was a good year for CFCU.

Audit Committee Report - Joanne Wallace gave a brief summary of the Audit Committee Report which is on page 8 of the AGM Booklet. Joanne thanked the committee members for their time and dedication along with Phyllis Amirault and her team, as well as Gloria Banks and her Grant Thornton team.

Appointment of Auditors - Motion by Joanne Wallace to retain Grant Thornton LLP for a three-year term of 2020, 2021, 2022. 2nd by Irvin Surette.

Motion carried.

Credit Committee Report - Yvon Boudreau went over the Credit Committee Report which is on page 9 of the AGM Booklet. The delinquency levels of loans at CFCU are 0.78% which is well below the guidelines of 2.0%. Total loan portfolio for CFCU totaled in excess of \$141 million representing an increase of \$13 million over the previous year end. Branch Managers, all lending staff, AI, and Holly should be commended for their adherence to policies and hard work.

Approval of Reports - Al Covey moved that the membership approve, as presented, the following reports: Chair of the Board of Directors' Report, Chief Executive Officer's Report, Auditor's Report, Financial Statements Report, Audit Committee Report, and the Credit Committee Report. 2nd by Brian Grant.

Motion carried.

Living our WHY - Our WHY (we do what we do) came about in June 2019 when the board of directors, management, and staff representatives assembled to create a new three-year strategic plan. The staff and board of CFCU are WHO make the credit union the success that it is and the WHAT is being a financial institution meeting the needs of our members. The WHY, however is much more and throughout 2019, CFCU had many examples of living its WHY such as supporting the School Breakfast Program, NSCC Urgent Aid Fund, Obama Event, volunteering in the community, partnering with the Yarmouth and Area Chamber of Commerce Doctor Recruitment Initiative, etc.

Nomination Committee Report - Ray Surette presented the Nomination Committee Report on page 10 of the AGM Booklet. There were five positions available: four three-year terms and one one-year term. The Nomination Committee recommended the Nominees, and since there were five Nominees and five positions, it was also recommended that all Nominees be elected by acclamation. To determine who would take the (shorter) one-year term, names were drawn to achieve a fair outcome. The following Nominees were confirmed as elected by the membership: Yvon Boudreau, Patrick Dempsey, Nikki Telford, and Joanne Wallace for threeyear terms as well as Charles Pothier for a one-year term. Moved by Ray Surette to accept the Nomination Committee Report, 2nd by Racheal Surette.

Motion carried.

Director's Awards - Raymond Doucette presented the following awards:

Chief Executive Officer's Report

The year 2020 will undoubtedly go down in recent history as one of the most challenging years ever. We witnessed a pandemic that caused a global economic crisis, loss of life, and a complete change to our daily routines and lives. Locally, some businesses shuttered as a result while others had to operate under strict government regulations. In addition, mental health issues were at an all-time high.

For the first time in our 83 years, the credit union had to temporarily close our doors to the public after the state of emergency was declared by our provincial government. Our primary focus was to protect our staff and members, while continuing to provide service to our members, albeit in a different way than we would normally. I am very proud of how our staff stood up to the challenge and worked very hard to ensure that all members were served during the lock down. Our staff also spent a great deal of time facilitating the federal and provincial governments' relief programs to ensure members received much-needed cash and loans. Interesting to note when conditions of the state of emergency eased, we saw a huge resurgence in the local housing market which drove housing prices up by over 60% in 1 year.

Community has always been at the center of who we are as an organization and why we exist. Nearly all local charitable and fund-raising events were negatively impacted in some way during 2020 and are at risk. CFCU stepped up and continued to support many organizations even though their events may have been cancelled. Some examples of our philanthropy include the local school breakfast program, farmers market, food bank, and the doctor recruitment initiative. Despite all the challenges faced by CFCU, 2020 was a good year financially. Earnings before taxes were just over \$1 million, and assets grew by over 12% to \$205 million. Managing our excess liquidity will be one of our biggest financial challenges in the foreseeable future.

Credit Committee Report

The Credit Committee is a valuable resource within the credit union having the mandate of overseeing and monitoring the lending function within policies as established by the board of directors. The committee reviews: loans granted to staff, directors, and committee members; loan rewrites/rescheduling; delinquency over 90 days; unauthorized overdrafts; and foreclosed properties. In addition, the committee reviews and makes recommendations regarding loan write-offs to the board of directors.

The 2020 year-end total loan portfolio for Coastal Financial Credit Union was comprised of 2619 accounts totaling \$141,481,968. This represents an increase of 1% or \$368,664 from the previous year end. In addition, our delinquency levels are well within the guidelines established by the Nova Scotia Credit Union Deposit Insurance Corporation (CUDIC) of 2%, with a year-end average of 0.48%. There was \$32,970.87 in loan write-offs and \$59,786.97 in loan recoveries.

There was a total of 46 loans referred to Lending Services, including commercial annual loan reviews and loan requests over the credit union lending limit. Lending Services is a department within Atlantic Central that is responsible for reviewing and approving loans above the credit union limits as established by CUDIC.

In closing, I would like to thank the members of the Credit Committee for their continuous co-operation and sincere dedication.

Youth Committee Report

Coastal Financial Credit Union's Youth Strategy Committee has restructured the way we operate our Youth Program. Although we were in the middle of a Global Pandemic in unprecedented times like we have never seen, with schools closing for the year after March Break, we still opened 95 new Youth Accounts during the 2020 school season. This was an all time high over the past number of years.

Once again, we continued our "Play for A's" program in which any graduating student who submitted a bursary application, and had marks over 90, were eligible to participate. For every grade of "A" or better received in either semester, their name was considered for a \$1,500 personal computer system with accessories from Cassa Office Plus. In June 2020, we chose the winners, and they were presented with a certificate for their system on graduation night. Based on the criteria, we presented two packages this year. The two lucky winners were Carson Duffus from Yarmouth Consolidated Memorial High School (YCMHS), and Christian d'Entremont from École secondaire de Par-en-Bas (ESPB).

In addition to the computer systems, we also presented five \$1,000 bursaries, one to each of the four local High Schools and one to a staff member's graduating student. Students must apply and write a short essay. This year, students were asked to comment on "Coastal Financial Credit Union offers banking services to your community. What technology does your financial institution provide that makes banking easier for you?" We had some very well thought out responses and we were pleased with all the applicants' efforts. Winners were Samuel LeBlanc – YCMHS, Calista Pulley – Drumlin, Alec d'Entremont – ESPB, Morgan Wickens – Barrington, and Christopher Pace – son of Andrew Pace. Congratulations to all our winners. In 2020 we once again had our "Design Our Corporate Christmas Card Contest". We had several hundred entries with all our elementary schools participating. Rick Doucette, CEO of Coastal Financial Credit Union, presented winner Greenlee LeBlanc, a grade 5 student from École Belleville, with a Star Saver bag of goodies including art supplies and credit union swag. A presentation was made to the school principal, Veronica Naud, for \$1,000 to be used at their school as she wished. Greenlee's winning design was Coastal Financial Credit Union's Corporate Christmas Card for 2020 and appealed to the judges as it was a peaceful winter scene in what felt like a crazy, unsettled year.

Our Youth Committee looks forward to 2021 as being an opportunity to continue to serve all youth in the communities we serve. In the words of Franklin D. Roosevelt:

"We cannot always build the Future for our Youth, but we can build our Youth for the Future."
